### President's Message: Michael Miller

Genealogists are sometimes a bit like dogs. Now, none of you should take that personally! It is really meant as a compliment when you realize just how perceptive dogs can be when it comes to recognizing one of the many overlooked animals of the forest; the squirrel. Perhaps many of you have seen the film "Up" where one of the animated feature's stars is a dog named "Dug." Now I had seen the film on the big screen with my then five year old twin boys and enjoyed the childlike humor expressed in the film that captured their immediate attention.

One recent afternoon, while into my third or fourth day of genealogical research at home, I decided to take a break and found myself looking through the few DVD's we purchased for the boys over the past few years to weed out the one's that needed to be donated to the next generation of younger, little people. I found the "Up" video and decided to sit down by myself to watch it again with a more "adult" focus on the film. My favorite character was Dug the dog. Now here is the "leap" into our shared world of genealogy...

I have a good friendship with a newly discovered distant cousin. He and I are very active in the pursuit of our genealogical background. We strive to understand as much the person(s) as we do their immediate surroundings and circumstances. We seek to learn as much as we can about the individual(s) first and then blend in the bigger picture of the history of the place(s) they have been surrounded by over their life.

This means our research efforts together start with one common purpose that we both have identified as the best place to start (our first squirrel). Invariably one of the two of us stumbles onto something else (our second squirrel) as we look for the first item we both agreed we would set out to prove. This new branch of thought begins another mental path of "oh, we need to get on to this too." So he and I agree that one of us will follow the first subject path we started with and the other will take the new idea (our second, first squirrel) and see where that idea leads. This same pattern then begins to happen to each of us independent of what the other is working on, constantly finding new elements (additional squirrels) we wish to explore on this ever widening path of discovery. Sometimes, both of us have then long forgotten the primary item (our first squirrel) we had set out to research in the first place (but not always).

So, without telling you too much about the movie (in case you haven't seen it), I think it is safe to say that many genealogists might be able to relate to Dug the Dog much like I did. In the movie, Dug would be engaged on a worldly pursuit with one of the other cast of characters and completely stop in his tracks; essentially freezing his current action to recognize something away from him that he felt much more relevant to his day/life at that moment; a squirrel. This happens throughout the film repeatedly. See any parallels? Ever experienced this?

I might only suggest what my cousin and I have found out to be a solution to our research "squirrels," we write down the original task we started with and then each subsequent squirrel moment we have (our diversions, our squirrels), so we don't lose track of things we know we want to come back to. We found in our early work together, we could not remember all of the squirrels we had seen and just where we had seen them... This form of brainstorming and allowing your perception to take you all over the map (so to speak) is often the most valuable discovery process a genealogist can have. Embrace your squirrels! So, as a suggestion, leave yourself a written trail through the woods to help you keep track of your squirrels. And, if you have time, take in a film.

graves moved from several "lost" burial sites of early Indiana settlers.

The John Hampden Holliday

Prize will be awarded to up to three individuals who make the most significant contributions to the field of Indiana pioneer history in works published in the years 2013, 2014, 2015 or 2016. The top prize will be the sum of five thousand dollars (\$5,000), with second and third prizes being awarded in lesser

amounts.

The prize will be awarded at a Centennial-Bicentennial Banquet in December of 2016, along with appropriate trophies. Nominations must be submitted on or before February 1, 2016.

# Food Heritage & Historic Mansions Wednesday, September 10, 2014

Price: \$136 per person

(Includes transportation, continental breakfast, luncheon, light dinner, admissions, gratuities, and donations to participating sites.)

Our glorious food heritage in Indiana will be showcased on the Fall Pilgrimage, which will have a "farm-to-table" theme and include visits to historic homes, with presentations about aspects of our Hoosier culinary history. Highlights will include a tour of Wick's Pies in Winchester, the largest maker in the country of Indiana's official "state pie": sugar cream pie. We will watch the process from making dough and forming the shell to filling and baking a pie at the multi-generational, familyowned business. Wick's also makes pecan, pumpkin, peanut butter cream and other pies. We also will visit Abbott's Candy in Hagerstown, which was founded in 1890 and owned by descendants of the same family until re-

cently. Abbott's is renowned for caramels and other candies. At the historic Huddleston Farmhouse, which was built by a Quaker family in 1841 on the Old National Road, we will tour historic, heirloom and community gardens as well as enjoy a tasting of various herbs. Joe Frost of Indiana Landmarks, the popular speaker at our 2013 annual luncheon, will make a presentation about the evolution of canning in Indiana homes. (Think of Mason Jars and the Ball Brothers.) Our day also will include visits to two stunning mansions - both on the National Register of Historic Places – that are intertwined with history in far-eastern Indiana. They are the Garr Mansion, which was built in 1876 and includes a farm machinery museum, and a mansion that was the lavish home of the Gennett family, owners of the renowned Starr Piano Company.

# Genealogist's Report – Michele Kerr

is for The Society of Indiana Pioneers. As we look forward to 2016 and the Centennial celebration of our group and the bi-centennial celebration of Indiana's statehood, interest in our group seems to be increasing. Just recently, I had an inquiry into membership solely because the prospective member wanted to be a part of this important time in Indiana's history.

More and more, I find that our current members are once again shaking their trees and deciding to add additional lines including spouses of approved ancestors and the ancestor's children who might also qualify within the cutoff date of 1840. If you are one we can help to make the additional line process even easier than the initial application.

When you originally applied for membership, you presented documentation on your generations leading back to your pioneer ancestor. If vou need only provide documentation on the generations that are different from your original application.

What an exciting time this to resubmit generation one's documentation (for yourself) because you have already done that in your initial application. To be helpful, please note that in the documentation area. I do ask that you go ahead and fill in the names, dates and places again in the additional line applications, but we do not need duplication of documentation (helps to save on paper as well!)

If your additional line applications are specifically for a spouse or child of an approved ancestor, it is actually just a matter of providing a new top sheet with the ancestor's particular information filled in and copies of pages 2-4 of the original application. If you have the original application stored on your computer or have a copy of those taking a look at your of it available, you can place own trees, please know that them under the new top sheet and simply send them into the office with your \$15 additional line fee. If you don't have a copy of your original application, please let us know and we can help with that as well.

please search for The Society of Indiana Pioneers and request to join our group. We currently have 95 members and I find that it is a great place to specifically mention upcoming items that are time sensitive and possibly of value to the members.

A note of interest: I recently came across a 1917 application where the applicant, Louisa Chitwood, provided an original letter dated May 31, 1832. She was the granddaughter of John Cope and Rebecca Ann Rariden. The letter was written to her father, Aquilla Rariden and has the front portion of the envelope that included her father's name and address. In her note to the Society, she wanted to join as a way to honor her Indiana Pioneer ancestor. [ I'm sure that the centennial celebration of Indiana's statehood in 1916 was one of the reasons that she felt compelled to join our group and submit such a wonderful document! As someone whose family didn't leave much in the way of historical memorabilia, this paper is extremely fascinating.]
